- I. <u>CALL TO ORDER</u> Chairman Barnhart called the meeting to order at 9:00 AM and led the Pledge of Allegiance.
- II. <u>WELCOME AND INTRODUCTIONS</u>—Chairman Barnhart welcomed those present. Meetings attendees introduced themselves.
- III. <u>APPROVAL OF AGENDA</u> The agenda was approved as presented.

1. <u>General Items</u> – There were no general items reported.

### 2. Radio Site Report

A. The new 160' tower has been installed at the Lower Badger radio site. Day Wireless Systems is currently working on re-hab for the existing shelter. The project continues to move forward. Director Fosse said that a letter was sent to surrounding property owners requesting their assistance to clear up outstanding boundary issues; Director Fosse has not received any response.

### 3. Staffing Report

- A. The three (3) individuals hired for Emergency Services Dispatcher positions are currently in the Training Academy. This classroom phase of training will continue until sometime at the end of December.
- B. One (1) tenured Emergency Services Dispatcher submitted a resignation letter; her last day of employment will be November 21, 2014. Her departure will create one (1) additional position vacancy.

## 4. State E911 Office Report

A. Director Fosse reported that RIVERCOM has been invited to attend an upcoming State E911 Policy Sub-Committee meeting to discuss regionalization. The meeting is yet to be scheduled but is expected to take place sometime in January or March. RIVERCOM is invited to share information, experience, and the impact of regionalization of 911 services.
