RiverCom Administrative Board members met on July 29, 2020 at 1:00 p.m. for the purpose of conducting a workshop to discuss the Shared Funding Assistance Program and to gather feedback from stakeholders about the Program.

As a starting point of discussion, Chairman Overbay raised the topic of the agency assessment fee model and the desire to stabilize the cost of user assessment fees for budgetary purposes. It was suggested that other metrics/factors may provide a better basis for agency assessments. Several ideas were further discussed by attendees.

Considering that agency assessment fees are included in RiverCom's Interlocal Cooperative Agreement, Executive Director Viebrock noted that she did not think a new assessment model could be accomplished for the 2021 budget cycle and that if all stakeholders approved a new model, we would need to plan out a considerable amount of time to prepare and implement.

Attendees discussed various concepts for the Shared Funding Assistance Program. There is currently no consensus about the future of the Program, although it is widely understood that program changes are needed.

Due to technical and communication difficulties, it was suggested the topic of discussion be resumed at a future meeting. Chairman Overbay asked that the Shared Funding Assistance Program and User Assessment Fees be placed on the agenda for the August 12, 2020 meeting.

There was no Board action taken at the workshop.

The Board adjourned the workshop at 3:30 p.m.
