- A. CALL TO ORDER Chairman Overbay called the meeting to order at 11:32 a.m.

Chairman Overbay stated that the final consulting report document will be made available as a public record. RiverCom will distribute copies of the report to employees.

E. CONSULTANT PRESENTATION - Bill Larson

Bill Larson provided a short biography and briefly reviewed a Scope of Work for consulting services that was distributed to Chairman Overbay on April 5, 2021 and subsequently to other Board members. If retained, his efforts would focus on administration and he would work directly with the Executive Director to prioritize and plan the recommendations of the Consultant report. The cost of the proposed scope of work is \$54,000. The assignment would start on April 12 and continue for a six-month period.

Motion to approve the Scope of Work dated April 5, 2021 as presented by Bill Larsen and to procure his services upon approval of the SOW by legal counsel; Sutton, second by Baker. Resolution: Motion carried unanimously.
