## G. OTHER BUSINESS

## 1. Business Case - Subscriber Equipment Sustainment Program

As requested by the Board at the December 14, 2022 meeting, Executive Director porter presented a full explanation of the benefits for this program which would eliminate the Tier 1 funds for preventative maintenance and allow for an additional Radio Technician for RiverCom to complete this in-house.

Assistant Chief Andy Davidson spoke about how huge this would be for their agency for both time and staff costs. It would save them roughly \$20,000 a year. WVF strongly recommends the approval of this program.

Further discussion took place.

Motion to approve the Subscriber Equipment Sustainment Program as presented; Crawford, second by Poirier.

## 2. Resolution 2023-1 - To amend the 2023 Annual Budget

With approval of the SESP business case, \$200,000 will be transferred from the Communications Tax Account to the General Operating Account. Dissolving the Tier 1 funds for agencies.

Motion to approve the amendment of the 2023 Annual Budget; Crawford, second by Poirier. Resolution: Motion Carried Unanimously

3. <u>Shared Funding Assistance Program Tier 2 Program – Cashmere Fire Department</u>
Chief Blake Larson presented a request for additional spending authority of \$13,000 to outfit the entire department with matching radios, a total of 12. The current radios are obsolete.

Motion to approve Cashmere Fire Department Tier 2 Application in full; Poirier, second by Crown. Resolution: Motion Carried Unanimously
