# 1. Administrative Services Manager

Administrative Services Manager Mihkaela Overbay reported on the following:

- a. New Radio Technician, Larry Moore began on April 3, 2023.
- b. Three (3) Telecommunicators began on April 10, 2023.
- c. Lateral Telecommunicator from MACC, in pre-employment process to start May 8, 2023.
- d. RiverCom attended the Military Job Fair at Ft. Lewis, and has two (2) high school career fairs coming up.

#### 2. Operations Manager

Operations Manager Jeremiah Johnson reported on the following:

- a. Expecting to have a third trainee fully signed off to her own shift soon.
- b. Wenatchee Valley Fire will be going live with their self-routing/push button response through iSpy, this is still a work in progress.

#### IT Manager

IT Manager Jerry Corder reported on the following:

a. IT staff attended the annual Spillman conference and learned there will be changes to the CJIS and FBI requirements. RiverCom is working on ways to become compliant with the upcoming changes.

#### 4. Radio Manager

Radio Manager Josh Humphrey reported on the following:

- Subscriber Program is underway, Chelan County Sheriff's Office is 85% complete and staff
  has begun to schedule fire and EMS to complete before fire season.
- Slide Ridge Radio Site is progressing, the forest service has approved building design and still working on tower details. The phase 1 contract with Day Wireless is in the final stages.
- c. Grouse Mountain radio site is currently down due to solar and battery issues. RiverCom is unbale to get to the site, due to the snow and road conditions. Still looking at options to get to the site for repair.
- d. Steve Crown asked Humphrey about agency expectations when it comes to the new preventative maintenance program.
- e. RiverCom met with Eastmont School District to work on coverage for both the high school and junior high schools. This will be included in the simulcast for both city police departments, to give both agencies better coverage areas. Goal is to be complete Fall 2023.
