# F. EXECUTIVE DIRECTOR REPORT

Executive Director Jones reported on the following:

#### 1. Customer Agency Survey

a. An electronic survey was sent out to all customer agencies asking for feedback on the RiverCom Telecommunicators and radio communication. Executive Director Jones presented the survey results to the Board. This survey will continue to be sent out every quarter.

## 2. Phone System Update

a. The consortium members have decided to collectively write a letter to Solacom, in reference of violating their contract. All members have signed the contract and sent it to Solacom. Discussion is ongoing, to exit the current contract.

### 3. Supervisor Recruitment

a. Supervisor application period has closed. Four (4) Telecommunicators applied and will interview on September 21, 2023. Thank you to those assisting on the panel.

# G. MANAGER REPORTS

#### 1. Administrative Services Manager

- a. Two (2) Telecommunicators resigned, our lateral hire has been signed-off to her own shift. There are two (2) trainees still with CTO's. Discussion took place on the resigned employees
- The training positions have been reclassified as Training Program Supervisor and Training Program Generalist, and have been moved under Administrative Services Division from Operations Division.
- c. Lori Beidler from Chelan County has accepted the GIS Analyst position and begins October 2, 2023.
- d. Implemented bilingual testing for our telecommunicator staff, as per their CBA it is an additional \$150 for being certified bilingual. One (1) Telecommunicator has recently taken and passed the exam.
- e. Teamster negotiations continue on October 2, 2023.
- f. Reminder for the Interlocal Cooperative Agreement workshop on November 1, 2023.

#### 2. IT Manager

IT Manager Corder reported on the following:

a. Currently looking at two (2) phone systems to replace Solacom, Central Square and Intrado Viper. Recently had demonstrations with both companies with our Telecommunicators, Operations Manager and IT. Three (3) Telecommunicators are travelling to NORCOM on September 20, 2023 to preview the Viper system.

Discussion took place.

b. Since going LIVE, Text-to-911 is going well.

#### 3. Radio Manager

Radio Manager Josh Humphrey reported on the following:

- a. Subscriber Program has completed preventative maintenance for all fire agencies. The program is going well and is receiving good response from agencies.
- b. Slide Ridge Radio Site building shelter is not set to arrive until November 2023 and the ordered generator motor has been discontinued, causing this project to not be complete until 2024.
- c. The Dam-to-Dam Simulcast project final equipment will arrive early October, with plan to install by mid-October.

## H. OTHER BUSINESS

1. Shared Funding Assistance Program Memorandum of Understanding (MOU) Update
Final MOU draft was presented to the Board. This changes the allocated fund process of tier 1
funds, with a new priority/needs-based application and approval process. Annually the Board will
set a shared funding balance, customer agencies will apply during the open application timeline
and the RiverCom Operations Group will approve the applications based on priority or need.

Concern of quotes expiring from application to purchase January 1 were discussed.
