- 1. Phone System Update
 - a. The consortium is still looking at vendors to narrow down a final decision. Hoping to utilize buying power, if RiverCom agrees with the same vendor. Translation for Text to 911 capabilities is the highest priority.
- 2. Spillman Test Environment
 - a. RiverCom is working with legal counsel for language that the Spillman Practice CAD is not accurate representation of records, making it unapplicable for public records. This was an issue brought up at a recent Spillman Records Conference.
