  - 1. Administrative Services Manager
    - a. Staffing update was given to the board:

Four (4) Telecommunicator Trainees are on the floor training with a CTO. The next Academy will begin January 13, 2025 with three (3) Telecommunicators. There will be another free testing on January 4, 2025 to begin building a hiring list.

The Information Systems Technician will begin on January 6, 2025.

- b. The November 22, 2024 Blood Drive had 34 donations.
- c. It has been decided that RiverCom will no longer be providing information to animal control effective December 17, 2024. Animal Control officers are not certified to have criminal justice database information.

#### 2. IT Manager

 RiverCom continues to work with Central Square on the upcoming phone system change in 2025.

## 3. Radio Systems Manager

- a. Preventative maintenance is complete for 2024, with a couple outliers as they have new equipment incoming and have chosen to wait.
- b. AVL equipment is installed, beta testing will occur over winter.
- c. November 17, 2024 was the first Fire Subcommittee meeting to find ways RiverCom and the fire departments can work together to meet needs.
- d. The 2025 shared funding increase to \$600,000 helped RiverCom approve \$593,083 of equipment for our user agencies. The users send thanks to the Board for approval of the increased allowance.

## OTHER BUSINESS

#### 1. Interlocal Cooperative Agreement

Three of the four legislature boards have voted and approved the amended agreement. City of Wenatchee is to vote in January. With the majority in support, the new voting board make up will take effect January 2025.

Dave Fennell will become the representative for the Fire Commissioners.

Discussion took place about language in section 7.01. New changes will need to be made to this section and will be sent to the Board for review. Once agreed upon, the agreement will need to be re-adopted and signed by all entities.
